

Public notice

Proposed Toucan Crossing, Signalised Toucan Crossing, and Footway/Cycle Track – A133 Clingoe Hill / St. Andrew's Avenue, Colchester

Notice is hereby given that Under Section 23 of the Road Traffic Regulations Act 1984 (as amended), Essex County Council proposes to establish Pedestrian Crossings on the following lengths of road.

1. To Implement: a 'Toucan Crossing'.

Road	Description
A133 Clingoe Hill / St. Andrew's Avenue	Eastbound: The centre line of the crossing is located approximately 25 metres east of the junction with Greenstead Roundabout. The width between give way lines is approximately 4 metres.

Zigzags for the above Eastbound Toucan Crossing will be installed approximately 16 metres on the western side and approximately 5 metres on the eastern side of the Toucan crossing, for the width of the road.

2. To Implement: a 'Signalised Toucan Crossing'.

Road	Description
A133 Clingoe Hill / St. Andrew's Avenue	Westbound: The centre line of the crossing is located approximately 55 metres east of the junction with Greenstead Roundabout. The width between give way lines is approximately 4 metres.

Notice is also hereby given that Under highway improvement powers given by sections 65 and 66 of the Highways Act 1980 and all other enabling powers, Essex County council proposes to **convert** sections of the following 'Verge' to a 'Shared and Segregated Footway/Cycle Track'.

3. Shared Footway/Cycle Track

Road	Description
A133 Clingoe Hill / St. Andrew's Avenue	Northern verge: (i) From a point approximately 20 metres east of the junction with Greenstead Roundabout, east for approximately 95 metres. (ii) From a point approximately 259 metres east of the junction with Greenstead Roundabout, east for approximately 43 metres, to the Salary Brook Bridge.

4. Segregated Footway/Cycle Track

Road	Description
A133 Clingoe Hill / St. Andrew's Avenue	Northern verge: From a point approximately 115 metres east of the junction with Greenstead Roundabout, east for approximately 144 metres. The width of the footway is approximately 2 metres. The width of the cycleway is approximately 2.5 metres.
