

**The Essex County Council (Various Roads, Elsenham)
(Combined 30mph and 40mph Speed Limits) Order 202***

The Essex County Council (“the Council”) in exercise of its powers under Section 82(2); 83(2); 84(1) and (2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (“the Act”) and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act hereby makes the following Order: -

1. No person shall cause any motor vehicle to proceed at a speed exceeding 30 miles per hour in the lengths of road, in the Parish of Elsenham, in the District of Uttlesford as specified in Schedule 1 to this order.
2. No person shall cause any motor vehicle to proceed at a speed exceeding 40 miles per hour in the lengths of road, in the Parish of Elsenham, in the District of Uttlesford as specified in Schedule 2 to this order.
3. No speed limit imposed by this order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with regulation 3 (5) of those regulations.
4. This Order shall come into operation on XXXXXXXXXXXXXXXX and may be cited as The Essex County Council (Various Roads, Elsenham) (Combined 30mph and 40mph Speed Limits) Order 202*
5. ‘The Essex County Council (Various Roads, Elsenham) (Speed Limits) Order 2007’ and ‘The Essex County Council (Various Roads, Elsenham) (Speed Limits) Order 2023’ are hereby revoked in their entirety however, any roads not mentioned above shall continue in force by virtue of this new Order.

Schedule 1 – 30MPH

Road	Description
Hall Road	From a point approximately 51 metres south-east from the centre of Golden Miller Avenue south-east for approximately 128 metres.
Bedwell Road	From its junction with New Road north-westwards for a distance of approximately 45.7 metres.
New Road	From its junction with Bedwell Road eastwards to a point approximately 29.5 metres east of its junction with Jenkins Drive, a distance of approximately 125 metres.
B1051 Stansted Road	From the most south-western boundary of the property known as Gilbey Cottage, south-westwards for a distance of approximately 350 metres.
B1051 Henham Road	From a point approximately 200 metres in an easterly direction from Hall Road, then in a generally north easterly direction for a distance of approximately 364 metres.

Schedule 2 – 40MPH

Road	Description
B1051 Henham Road	From a point approximately 564 metres east and north-eastwards from its junction with Hall Road for a distance of approximately 266 metres.
