

The Essex County Council (Colchester City) (Prohibition of Waiting, Loading and Stopping) and (On-Street Parking Places) (Civil Enforcement Area) (Amendment No.83) Order 202*

The Essex County Council (hereinafter referred to as “The Council”) in exercise of its powers under Sections 1(1), 2(1) to (3), 3(2), 4(1), 4(2), 32(1), 35(1), 45, 46, 49, 53 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (as amended) (hereinafter referred to as “the Act”), and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act, hereby make the following Order: -

- 1. This order shall come into operation on ***** and may be cited as The Essex County Council (Colchester City) (Prohibition of Waiting, Loading and Stopping) and (On-Street Parking Places) (Civil Enforcement Area) (Amendment No.83) Order 202*.

Schedule

1. To Revoke: 'Disabled Badge Holders Only' Bay.

Road	Description
Greenstead Road	South Side: From the western side of property 69 Greenstead Road, southeast for approximately 5.5 metres.
Lisle Road	South Side: From the boundary of properties 27 and 29 Lisle Road, east for approximately 5.5 metres.

2. To Revoke: 'Permit Parking Area B1' and **Implement:** 'Disabled Badge Holders Only' Bay.

Road	Description
Beaconsfield Avenue	South Side: From the south-eastern side of property 46 Beaconsfield Avenue, northwest for approximately 5 metres.

3. To Revoke: 'Permit Holders Only B2 Mon-Sat 8am-6pm' and **Implement:** 'Disabled Badge Holders Only' Bay.

Road	Description
Butt Road	Northwest Side: From the south-western boundary of property number 123 Butt Road, northeast for approximately 4.5 metres.

4. To Revoke: 'Residents Permit Parking Area C1' and **Implement:** 'Disabled Badge Holders Only' Bay.

Road	Description
Golden Noble Hill	East Side: From a point approximately 1.5 metres south of the boundary of properties 17 and 18 Golden Noble Hill, south for approximately 5 metres.

5. To Revoke: 'Permit Holders Only C2 Mon-Sat 8am-6pm' and **Implement:** 'Disabled Badge Holders Only' Bay.

Road	Description
Granville Road	West Side: From the boundary of properties 38 and 40 Granville Road, north for approximately 4.5 metres.

6. To Upgrade: 'Advisory Disabled Bay' to **Enforceable** 'Disabled Badge Holders Only' Bay.

Road	Description
Penrice Close	North Side: From the boundary of properties 28 and 29 Penrice Close, east for approximately 5 metres.
