

**The Essex County Council (Various Roads, Halstead)  
(Restricted Road and 40mph Speed Limit) Order 202\***

The Essex County Council (hereinafter referred to as ("The Council")) in exercise of its powers under Sections 81, 82(2) and 83(2), 84(1)(a) and (2), and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act") (as amended), and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act, hereby make the following Order: -

1. The length of road specified in Schedule 1 to this Order shall become restricted roads for the purposes of Section 81 of the Act.
2. No person shall cause or permit any vehicle to proceed at a speed exceeding 40 miles per hour in the said length of roads in the Parish of Halstead in the District of Braintree as specified in schedule 2 to this Order.
3. No speed restriction imposed by this Order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with regulation 3(5) of those Regulations.
4. The restriction imposed by this Order shall be in addition to and not in derogation of any restrictions or requirements imposed by any regulations made or having effect as if made under the Act or by or under any other enactment.
5. 'The Essex County Council (A131 Mount Hill and Oak Road, Halstead) (Restricted Road and 40MPH Speed Limit) Order 2022 is hereby revoked in its entirety. The restrictions contained within that Order shall continue in force by virtue of this Order.
6. This Order shall come into operation on ... ..... 202\* and may be cited as The Essex County Council (Various Roads, Halstead) (Restricted Road and 40mph Speed Limit) Order 202\*

### **Schedule 1 – Restricted Road**

<b>Road</b>	<b>Description</b>
A131 Mount Hill	From the terminal point of the existing 30MPH speed limit located approximately 79 metres south of its junction with Trinity Road, generally south-westwards to a point approximately 122 metres south west of its junction with White Horse Avenue, a total distance of approximately 590 metres.

### **Schedule 2 – 40mph Speed Limit**

<b>Road</b>	<b>Description</b>
Tidings Hill	From a point approximately 13 metres southwest of its junction with Grange Close (where the existing 30mph speed limit ends) in a south westerly direction for approximately 146 metres.
Edwards Avenue	From its junction with Tidings Hill north west for approximately 6.5 metres.
A131 Mount Hill	From a point approximately 122 metres south west of its junction with White Horse Avenue, south west for a distance of approximately 440 metres.
Oak Road	From its junction with A131 Mount Hill, in a south-easterly direction for a distance of approximately 10 metres to its junction with the existing 30MPH speed limit.
