## **Public notice**

Implementation of Cycle Track and Crossing – B1030 White Hart Lane, (Springfield and Chelmsford Garden Parishes) in the City of Chelmsford.

**Notice is hereby given** that under Sections 23 of the Road Traffic Regulation Act 1984 (as amended) the Essex County Council proposes to install the following traffic signal-controlled junction.

1. To Implement a 'Toucan Crossing'

**Location**: B1030 White Hart Lane (Springfield & Chelmsford Garden parishes, in the City of Chelmsford

Effect of the changes: To implement a Toucan Crossing on B1030 White Hart Lane:

- (i) The **Centre line** of the crossing will be located approximately 213 metres west of the western junction of Centenary Way and B1030 White Hart Lane.
- (ii) The **width** of the crossing between stop 'give way' lines will be approximately 10 metres.
- (iii) The **width** of the dropped kerbs will be approximately 4 metres.
- (iv) Crossing Zigzags

Approximately 17.5 metres - to the east of the Crossing Approximately 17.5 metres - to the west of the Crossing

2. Notice is also hereby given that under highway improvement powers given by Section 65 and 66 of the Highways Act 1980 the Essex County Council proposes to **Implement a shared unsegregated cycle track** at the following locations:

B1030 White Hart	From a point approximately 215 metres west of the western junction with
Lane	Centenary Way, in an easterly then northerly direction for approximately 160
(Northern Side)	metres, to the pedestrianised area between The Beaulieu Park School and
,	Beaulieu Community Centre
