

# Public notice

## The Essex County Council (Tendring District) (Prohibition of Waiting, Loading and Stopping) and (On-Street Parking Places) (Civil Enforcement Area) (Amendment No.51) Order 202\*

**Notice is hereby given** that the Essex County Council proposes to make the above Order under sections 1(1), 2(1) to (3), 3(2), 4(1), 4(2), 32(1), 35(1), 45, 46, 49, 53 and Parts III and IV of Schedule 9 of the Road Traffic Regulation Act 1984 (as amended)

### Effect of the Order:

#### 1. To Revoke: 'Disabled Badge Holders Only' Bays on the following lengths of road:

Road	Description
Eton Road, Clacton	<b>North Side:</b> From a point in line with the boundary of property numbers 3 and 5 Eton Road, eastwards for approximately 6.0 metres.
St Osyth Road, Little Clacton	<b>North Side:</b> From a point approximately 3.5 metres west of the boundary of No's 120 and 122 St Osyth Road, west for approximately 5 metres.
Grove Avenue, Walton	<b>East side:</b> From a point in line with the boundary of property numbers 17 and 19 Grove Avenue, southwards for approximately 5.8 metres.
Naze Park Road, Walton	<b>North side:</b> From a point approximately 10 metres from its junction with First Avenue, west for approximately 5.5 metres.
Lee Road, Harwich	<b>South side:</b> From a point approximately 0.5 metres southwest of the boundary of property numbers 43 and 45 Lee Road, westwards for approximately 5.5 metres.
Park Road, Harwich	<b>Southwest side:</b> From a point in line with the boundary of property numbers 25 and 26 Park Road, southwards for approximately 5.5 metres.

#### 2. To Upgrade: (from Advisory to enforceable) Disabled Badge Holders Only

Road	Description
Marlborough Close, Clacton	<b>West side:</b> From a point in line with the south western side wall of Firethorn House, south west for approximately 5 metres.
Carrs Road, Clacton	<b>West side:</b> From a point in line with the boundary of property numbers 25 and 27 Carrs Road, southwards for approximately 5.0 metres.
Leas Road, Clacton	<b>East side:</b> From a point approximately 7 metres from the boundary of property numbers 1-11 and 15-25 south west for approximately 5.5 metres.
