

Public notice

The Essex County Council (Braintree District) (Prohibition Of Waiting, Loading And Stopping) and (On-Street Parking Places) (Civil Enforcement Area) (Amendment No.50) Order 202*

Notice is hereby given that the Essex County Council proposes to make the above Order under Sections 1(1), 2(1) to (3), 3(2), 4(1), 4(2), 32(1), 35(1), 45, 46, 49, 53 and Parts III and IV of Schedule 9 of the Road Traffic Regulation Act 1984 (as amended).

Effect of the order:

1. To Revoke: Disabled Badge Holders Only and **To implement:** 'Resident Permit Holders Only 3'

Road Name	Description
Manor Street, Braintree	North side: From a point approximately 3 metres west of the boundary of 33 and 35 Manor Street, west for approximately 6 metres
Manor Street, Braintree	South side: From the eastern boundary of 74 Manor Street, west for approximately 6 metres

2. To Revoke: Disabled Badge Holders Only and **To implement:** 'No Waiting Mon-Fri 11.30am - 12.30pm'

Road Name	Description
Homefield Road, Witham	North side: From a point approximately 2 metres east of the western boundary of 13 Homefield Road, west for approximately 5 metres
Homefield Road, Witham	North side: From a point in line with the boundary of 17 and 19 Homefield Road, east for approximately 13 metres. (2 bays)

3. To Revoke: Disabled Badge Holders Only and **To implement:** 'Resident Permit Holders Only RR1'

Road Name	Description
Rayne Road, Braintree	South side: From the eastern boundary of 251 Rayne Road, west for approximately 5 metres.

4. To Revoke: Disabled Badge Holders Only

Road Name	Description
George Road, Braintree	East side: From the boundary of 14 and 16 George Road, north for approximately 7 metres.
Fal Drive, Witham	East side: From a point approximately 6 metres east of the east wall of 4 Fal Drive, east for approximately 3 metres (Middle Bay)

5. To Upgrade (from Advisory to Enforceable) Disabled Badge Holders Only

Road Name	Description
Coldnailhurst Avenue, Braintree	East side: From a point approximately 8 metres north east of the shared property boundary of No's 2 and 4 Coldnailhurst Avenue, north east for approximately 2.5 metres
Honeysuckle Way, Witham	North side: From a point approximately 18 metres west of a point in line with the front wall of the house 93 Honeysuckle Way west for approximately 5 metres
