

Public notice

The Essex County Council (Uttlesford District) (Prohibition of Waiting, Loading and Stopping) and (On-Street Parking Places) (Civil Enforcement Area) (Amendment No.40) Order 202*.

Notice is hereby given that Essex County Council proposes to make the above order under S1(1), 2(1) to (3), 3(2), 4(1), 4(2), 32(1), 35(1), 45, 46, 49, 53 and Parts III and IV of Schedule 9 of the Road Traffic Regulation Act 1984 (as amended) on the following lengths of road in the Parish of Takeley in the District of Uttlesford

Effect of the Order

1. To Revoke: No Stopping at Any Time on Carriageway, Footway & Verge

Road	Description
Parsonage Road	Both sides From its junction with Coopers End Roundabout southwards to its junction with Mill Race Drive, a distance of approximately 1372m.

2. To Revoke: 'No waiting at any time.

Road	Description
Parsonage Road	West side i. From a point approximately 17 metres north of its junction with Garnetts southwards to a point approximately 17 metres south of that junction ii. From a point approximately 15 metres north of its junction with Chestnut Way southwards to a point approximately 13 metres south of that junction iii. From a point approximately 8 metres north of its junction with B1256 Dunmow Road northwards for approximately 63 metres East side iv. From a point approximately 16 metres south of its junction with Weston Group Access Road (Hatfield Way) southwards for approximately 53m v. From a point approximately 17 metres north of its junction with Roseacres southwards to a point approximately 17 metres south of that junction vi. From a point approximately 8 metres north of its junction with B1256 Dunmow Road northwards for approximately 59 metres
Garnetts	Both sides From its junction with Parsonage Road westwards for approximately 13 metres.
Chestnut Way	North side From its junction with Parsonage Road westwards for a distance of approximately 10 metres South side From its junction with Parsonage Road westwards for a distance of approximately 6 metres
Roseacres	Both Sides From its junction with Parsonage Road eastwards for approximately 12 metres



3. To Revoke: 'No Waiting Mon-Fri 10am to 11am,

Parsonage Road	West Side: From a point approximately 18 metres south of its junction with North Street, southwards for approximately 45 metres.

4. To Implement: 'No Stopping at Any Time' Restrictions.

Parsonage Road	West Side: (i) From its junction with Mill Race Drive Roundabout southwards for approximately 41 metres. (ii) From a point approximately 60 metres south of its junction with Mill Race Drive Roundabout southwards for approximately 87 metres. (iii) From a point approximately 28 north of its junction with Garnetts South for approximately 122 metres to a point approximately 86 metres north of B1256 Dunmow Road. (iv) From a point approximately 28 north of its junction with Garnetts South for approximately 122 metres (v) From a point approximately 62 metres south of its junction with North Road southwards to a point approximately 86 metres north of its junction with B1256 Dunmow Road (vi) From a point approximately 8 metres north of its junction with B1256 Dunmow Road northwards for a distance of approximately 63 metres East Side: (i) From its junction with Mill Race Drive Roundabout southwards for approximately 75 metres. (ii) From a point approximately 95 metres south of its junction with Mill Race Drive Roundabout southwards to a point 16 metres south of its junction with Weston Group Access/ Hatfield Way (iii) From a point 35 metres south of its junction with Weston Group Access/ Hatfield Way southwards to a point 17 metres of its junction with Roseacres (iv) From a point 36 metres south of its junction southwards to a point 8 metres north of its junction with B1256 Dunmow Road Eastern Arm off Mill Race Drive Roundabout From its junction with Mill Race Drive Roundabout eastwards for 5 metres
Mill Race Drive Roundabout	The entire circulatory of the roundabout.
Mill Race Drive	Both Sides: From its junction with Mill Race Drive Roundabout westwards for approximately 26 metres
Hatfield Way/Weston Group Access	Both sides: From its junction with Parsonage Road eastwards for approximately 20 metres
Garnetts	Both sides: From its junction with Parsonage Road westwards for approximately 13 metres
North Road	North side: From its junction with Parsonage Road eastwards for approximately 6 metres South side:

	From its junction with Parsonage Road eastwards for approximately 5 metres
South Road	North side: From its junction with Parsonage Road eastwards for approximately 8 metres South side: From its junction with Parsonage Road eastwards for approximately 7 metres
Chestnut Way	North side: From its junction with Parsonage Road westwards for approximately 10 metres South side From its junction with Parsonage Road westwards for approximately 6 metres
Roseacres	Both Sides: From its junction with Parsonage Road eastwards for approximately 12 metres

5. To Implement: No Waiting at any time

Road	Description
Parsonage Road	Both sides: From its junction with Coopers End Roundabout southwards for a distance of 1345 metres to the parallel crossing north of Mill Race Drive Roundabout.

From a point 18 metres south of its junction with North Road southwards for 41 metres iii. From a point 71metres north of its junction with B1256 Dunmow Road northwards for 15 metres East side: iv. From a point 75 metres south of its junction with Mill Race Drive Roundabout southwards for 90 metres v. From a point 16 metres south of its junction with Weston Group Access/Hatfield Way southwards for 19 metres vi. From a point 17 metres south of its junction with Roseacres southwards for 19 metres

Parsonage Road – Parallel Crossing

Notice is hereby given that Essex County Council proposes to install a parallel crossing under section 23 of the Road Traffic Regulation Act 1984 (as amended) at the following location.

Road	Description
Parsonage Road	Centre of the crossing will be at a point 14 metres north of the junction with Mill Race Drive Roundabout

The width between the give way lines of the crossing will be 6.5 metres and the crossing zig zags will extend for 17 metres north of the northern give way line and 11 metres south of the southern give way line.
