Installation of Puffin Crossing on B1012 Burnham Road, South Woodham Ferrers, Chelmsford

Notice is hereby given that under Sections 23 of the Road Traffic Regulation Act 1984 the Essex County Council proposes to install a Puffin Crossing on the following length of road:

Proposed Puffin Crossing

Road	Description
NORTHBOUND CARRIAGEWAY B1012 Burnham Road, South Woodham Ferrers	The centre line of the crossing is located approximately 35 metres northeast of its junction with the Willow Grove/Ferrers Road Roundabout and measures approximately 8.2 metres between give-way lines.
SOUTHBOUND CARRIAGEWAY B1012 Burnham Road, South Woodham Ferrers	The centre line of the crossing is located approximately 42 metres northeast of its junction with the Willow Grove/Ferrers Road Roundabout and measures approximately 8.2 metres between give-way lines.

Proposed Puffin Crossing Zig-Zags

Road	Description
NORTHBOUND CARRIAGEWAY B1012 Burnham Road, South Woodham Ferrers	<ol style="list-style-type: none">1. From its junction with the southern side of the Puffin Crossing, in a south westerly direction for a distance of approximately 17.5 metres.2. From its junction with the northern side of the Puffin Crossing, in a north easterly direction for a distance of approximately 4.5 metres.
SOUTHBOUND CARRIAGEWAY B1012 Burnham Road, South Woodham Ferrers	<ol style="list-style-type: none">1. From its junction with the southern side of the Puffin Crossing, in a southerly direction for a distance of approximately 17.9 metres.2. From its junction with the northern side of the Puffin Crossing, in a north easterly direction for a distance of approximately 25.8 metres.
