

Public notice

The Essex County Council (Harlow District) (Prohibition of Waiting, Loading and Stopping) and (On-Street Parking Places) (Civil Enforcement Area) (Amendment No.57) Order 202*

Notice is hereby given that the Essex County Council proposes to make the above Order under Sections 1(1), 2(1) to (3), 3(2), 4(1), 4(2), 32(1), 35(1), 45, 46, 49, 53 and Parts III and IV of Schedule 9 of the Road Traffic Regulation Act 1984 (as amended).

Effect of the order:

- 1. TO REVOKE:** 'Disabled Badge Holders Only' restrictions on the following length of roads in the District of Harlow as specified:

| The Downs, Harlow | NORTHWEST SIDE: From a point approximately 3 metres southeast of the southeast building line of 102 The Downs, south-easterly for approximately 5 metres Parkmap Tile: TL450 097 - Revision 0 to Revision 1 |
| Wharley Hook, Harlow | NORTH SIDE: From a point in line with the shared boundary of 90 and 91 Wharley Hook, easterly for approximately 5.4 metres. Parkmap Tile: TL455 080 Revision 1 to Revision 2 |

- 1. TO IMPLEMENT:** Disabled Badge Holders Only Bay' restrictions on the following length of roads in the District of Harlow as specified:
