

The Essex County Council (Chelmsford City) (Prohibition of Waiting, Loading and Stopping) and (On-Street Parking Places) (Civil Enforcement Area) (Amendment No.75) Order 202*

The Essex County Council in exercise of its powers under S1(1), 2(1) to (3), 3(2), 4(1), 4(2), 32(1), 35(1), 45, 46, 49, 53 and Parts III and IV of Schedule 9 of the Road Traffic Regulation Act 1984 (“the Act”) and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act 1984 (as amended), hereby make the following Order: -

1. This Order shall come into operation for all purposes on the ** day of ***** 202* and may be cited as The Essex County Council (Chelmsford City) (Prohibition of Waiting, Loading and Stopping) and (On-street Parking places) (Civil Enforcement Area) (Amendment No.75) Order 202*.

2. This Order will be incorporated into The Essex County Council (Chelmsford City) (Prohibition of Waiting, Loading and Stopping) and (On-street Parking places) (Civil Enforcement Area) Consolidation Order 2019’ by substituting Map Tiles:

3. The restriction imposed by this Order shall be in addition to and not in derogation of any restrictions or requirements imposed by any regulations made or having effect as if made under the Act or by or under any other enactment.

SCHEDULE:**1. To introduce 'No Waiting at Any Time'.**

Plumtree Avenue, Great Baddow	Both sides – from a point 15 metres southeast of its junction with the southern kerb line of Gowers Avenue north-westwards to a point 15 metres northwest of its northern kerb line with Gowers Avenue. Map tile - TL725 047
Gowers Avenue, Great Baddow	Both sides – from its junction with Plumtree Avenue westwards for 15 metres. Map tile - TL725 047
Park View Crescent, Great Baddow	Both sides – from the boundary of Nos.40b & 40c Park View Crescent extending south-eastwards then north-eastwards to the south-western property boundary of No.38 Park View Crescent. Map tile – TL725 042
Worcester Court, Great Baddow	Both sides – from the centre of its junction with Park View Crescent south-eastwards for 10 metres. Map tile – TL725 042

2. To remove 'Permit Holders Only Monday to Saturday 8am-11pm Zone 4' and introduce 'No Waiting at Any Time'.

Lady Lane, Chelmsford	Southwest side – from a point 13 metres southeast of its junction with Burns Crescent extending south-eastwards to a point 15 metres southeast of its junction with Lynmouth Avenue. Map tile – TL710 057
