

Terms and Conditions for Army and Navy flyover competition

Prizes: The competition winner will receive a £75 voucher for Evans Cycles in Chelmsford. The winner's school will also receive a round-shaped Scooterpod (RRP £532). Who can enter: Any child aged between 4 and 11 on the closing date can enter the competition, providing they are a registered pupil at a primary/infant/junior school within the Chelmsford City Council administrative area. - 4. Any entry not from someone eligible to enter will be disqualified
