## BRAINTREE DISTRICT COUNCIL WITH ESSEX COUNTY COUNCIL LOCAL HIGHWAY PANEL – 24<sup>th</sup> SEPTEMBER 2015 2015/16 POTENTIAL CAPITAL SCHEMES

From the scheme recommendations made by the Panel in 2014/15 there were schemes to the value of £356,000 re-profiled for delivery within the 2015/16 financial year. The Panel recommendations against the 2015/16 Capital Budget of £815,578 were £830,250.

This will ensure a recommended 2015/16 Capital Budget of £1,186,250 and will allow for the development of the rolling programme into 2016/17.

The following list identifies all of the scheme requests which have fed into the Braintree LHP. The RAG column acknowledges what the status of the scheme request is as below:



= The scheme has been validated as being feasible and is available for consideration.



= The scheme has previously been approved for a feasibility study and the results are awaited before the scheme can be fully considered.
