### 1 **DECLARATIONS OF INTEREST**

The following interests were declared:-

Councillor J Abbott declared a non-pecuniary interest in Agenda Item 8 - Schemes for Consideration by the Panel and specifically scheme LBRA152089 Park Road and the Northern section of Church Road, Rivenhall - A review of current measures including signage and lining and consideration of possible measures such as a speed limit reduction and no overtaking markings, as he lived in Park Road, Rivenhall.

Councillor M Banthorpe declared a non-pecuniary interest in Agenda Item 6 - Braintree District Local Highways Panel Budget and specifically scheme LBRA152020 Brunwin Road j/w Shalford Road, Rayne – Extension of double yellow lines to 29 Shalford Road as Braintree District Council's Elected Member for Rayne.

Councillor R Mitchell declared a non-pecuniary interest in Agenda Item 8 – Schemes for Consideration by the Panel and specifically scheme LBRA003001 Inworth Road, Feering - New footway, as he was a resident of Inworth Road.

Councillor D Smith declared a non-pecuniary interest in Agenda Item 6 - Braintree District Local Highways Panel Budget and specifically scheme LBRA152020 Brunwin Road j/w Shalford Road, Rayne – Extension of double yellow lines to 29 Shalford Road as a Member of Rayne Parish Council.

In accordance with the Code of Conduct, Councillors Abbott, Banthorpe, Mitchell and Smith remained in the meeting and took part in the discussion when the Items were considered.

## 2 **MINUTES**

**DECISION:** That the Minutes of the meeting of Braintree District Local Highways Panel held on 18th January 2016 be approved as a correct record and signed by the Chairman.

## 3 **MATTERS ARISING**

### **INFORMATION:**

#### **Minute 3 – Matters Arising (Minute 5 - Braintree District Local Highways Panel Budget)**

Members of the Panel were advised that it had not been possible to submit a detailed report on performance against the budget to this meeting as the final figures on completed schemes would not be available until the end of April 2016.

## 4 **QUESTION TIME**

**INFORMATION:** There were four statements made. Details of the people who spoke at the meeting are contained in the Appendix to these Minutes. The comments made are summarised below.

Councillor Sparks reiterated Earls Colne Parish Council's support for the extension of the 40mph speed limit by 300m at B1024 Coggeshall Road, South of America Road, Earls Colne on the ground that it would improve safety. Councillor Sparks stated that the proposed scheme had the support of Braintree District Council and Essex County Council Members also. It was subsequently agreed by the Panel, that although this scheme did not meet

the required criteria, it should be referred to the Cabinet Member for Highways Delivery for consideration with the support of the Chairman of the Panel (Minute 7 refers).

Councillor Mrs Cunningham indicated that an additional pedestrian crossing located near to the junction of Cressing Road and Stubbs Lane, Braintree was required due to an increase in the number of pupils attending Alec Hunter Academy who crossed Cressing Road at this point. Councillor Mrs Cunningham reported that a child had been knocked down by a car and had suffered head injuries. A safe passage for children going to and from school was required.

**Matt Valentine, Essex Highways stated that, subject to a feasibility study being approved, a report on this scheme would be submitted to a future meeting of the Panel.**

Mr Konig indicated that the description of the proposed work relating to scheme LBRA142037 – Broad Road, Braintree should state 'speed limit extended to 30mph to Thistley Green Road.' Mr Konig expressed concern that since the last meeting of the Panel the anticipated completion date of this scheme had been put back from May 2016 to November 2016 without explanation and that this was now the fifth completion date that had been given. Mr Konig expressed concern about the high speed of vehicles and the affect on vulnerable members of the community including those at Fern Lodge Residential Home for disabled people, Larch Wood Care Home for the elderly and Cypress Gardens for people with a learning disability who had to cross Broad Road. Mr Konig asked the following questions:-

1. Every scheme in the later year than this one has an earlier implementation date. Why?
2. The latest implementation date is now the fifth date given. Why have there been so many slippages and what are the reasons?
3. What assurance can be given that this is the last and final date that the new speed limit will actually be put into operation? Will Members and Officers ensure that this is done by this date, if not earlier?

**Matt Valentine, Essex Highways agreed to forward the information requested to Mr Konig by E-Mail and to copy the E-Mail to all Members of Braintree District Local Highways Panel. A report would also be presented to the next meeting of the Panel to explain why the implementation date had slipped.**

Councillor Lager commented as follows:-

Scheme LBRA152014 – Cut Throat Lane, Witham  
Has this scheme been approved? It does not represent value for money and it is not a high priority.

**Action By: Alison Webb to check past Minutes to clarify if the scheme has been approved.**

Scheme LBRA142006 – B1018 Braintree Road, Cressing  
Support putting this scheme on hold.

Scheme LBRA162004 - Chipping Hill Bridge, Chipping Hill j/w Powers Hall  
End, Witham

On 15th February 2016 Witham Town Council supported recommendations put forward by Essex County Council Highways to improve visibility, but did not consider that traffic lights would be an appropriate solution in the Conservation Area. Witham Town Council suggested that the stop line on the Chipping Hill side of the bridge should be moved back.

Scheme LBRA162005 - Chipping Hill, Witham  
No objection.

Scheme LBRA162006 - Guithavon Valley, Witham

A raised platform in the road would be more effective. The passageway is very rarely used and could be closed.

Scheme LBRA162008 - Pelly Avenue, Witham

Suggest put this on hold pending the publication of Witham Town Council's report on parking.

Scheme LBRA162010 - Mill Lane/Guithavon Valley, Witham  
Witham Town Council opposed the installation of 'domes'.

Scheme LBRA162014 - Guithavon Valley, Witham

A raised platform at the junction of Guithavon Valley and Guithavon Rise would be a better solution.

Scheme LBRA152140 - B1389 Hatfield Road, Witham

Significant additional housing is likely adjoining Hatfield Road and a more strategic approach is required to enable people on foot to cross the road safely.

Scheme LBRA162028 - Rectory Lane, Rivenhall

Rectory Lane from Forest Road to the Old Rectory/Lodge should be closed to vehicular traffic in view of significant additional housing expected in the future. (Councillor Lager was advised that such a proposal would have to be dealt with separately to the Quiet Lane proposal).

## 5 **BRAINTREE DISTRICT LOCAL HIGHWAYS PANEL BUDGET**

**INFORMATION:** Details of Braintree District Local Highways Panel's capital and revenue budgets were reported.

It was noted that on 9th February 2016 Essex County Council had agreed its budget for the forthcoming financial year, which included a decision to reduce the funding allocated to Local Highways Panels by half. This meant that

capital funding amounting to £407,789 would be available for expenditure by Braintree District Local Highways Panel in 2016/17.

Members were advised that, in the circumstances, schemes which had already been recommended by the Panel for approval but had yet to be implemented had been re-profiled to be delivered and funded from the 2016/17 budget. These schemes, the details of which are set out below, had a total value of £440,000.

### Re-profiled Schemes

LBRA142018 – Installation of a central safety refuge, junction of Bridge Street and Colchester Road, Bures Hamlet  
Predicted Spend in 2016/17 - £23,000

LBRA142020 – Installation of kerbing to over-run area due to continual damage to the village green, Colneford Hill/Colne Park Road, White Colne  
Predicted Spend In 2016/17 - £18,000

LBRA142021 – Installation of concrete kerbing around the Colne Park Road section of the village green, Village Green, White Colne  
Predicted Spend in 2016/17 - £4,100

LBRA142037 – Extension of 30mph speed limit signs, Broad Road, Braintree  
Predicted Spend in 2016/17 - £7,000

LBRA141001 – Casualty reduction scheme, Deanery Hill/Church Lane, Bocking  
Predicted Spend in 2016/17 - £2,000

LBRA142061 – Installation of 2 No. additional height restriction warning signs North and South bound, Coggeshall Road, Feering  
Predicted Spend in 2016/17 - £6,800

LBRA142122 – Extension of the existing 30mph speed limit North by an additional 100 metres, Church Road, Rivenhall  
Predicted Spend in 2016/17 - £6,000

LBRA151002 – Casualty reduction scheme, Courtauld Road, North-bound approach to Julien Court Road, Braintree  
Predicted Spend in 2016/17 - £4,500

LBRA152002 – Installation of a 20mph speed limit in the vicinity of St Giles Primary School, Church Street, signage and Traffic Regulation Order (including lit terminal signs) Church Street, Great Maplestead  
Predicted Spend in 2016/17 - £7,000

LBRA152008 – Installation of signage and Traffic Regulation Order for 7.5T weight limit, Castle Hedingham  
Predicted Spend in 2016/17 - £31,800

LBRA152011 – Feasibility study. The survey results have highlighted a problem with vehicles entering and exiting Inworth Road. The feasibility study will provide a report of what can improve the junction with cost options.  
London Road j/w Inworth Road, Feering  
Predicted Spend in 2016/17 - £15,500

LBRA152014 – Conversion of two pedestrian accesses to ramped access; upgrading one pedestrian access steps with handrail, Cut Throat Lane, Witham  
Predicted Spend in 2016/17 - £24,120

LBRA152016 – Installation of 30mph roundel at top of Dragons Teeth by the 30mph speed limit terminal sign along London Road and Inworth Road, Entrances to Feering Village  
Predicted Spend in 2016/17 - £1,000

LBRA152020 – Extension of the double yellow lines (approximately 20m) along Shalford Road to the top of the ramp outside property No. 29, Brunwin Road j/w Shalford Road, Rayne  
Predicted Spend in 2016/17 - £1,000

LBRA152070 – Installation of new signage and re-routing of HGVs to stop the conflict of HGVs getting stuck along this road, Oak Road, Rivenhall  
Predicted Spend in 2016/17 - £44,000

LBRA152060 – Removal of the two Church End arms of the junction and in their place provide a single arm square to the road. This would reduce the number of conflict points from three to one. This would also involve installing new kerbing at the bell mouth, Ashton's Corner, B1053 Braintree Road j/w Panfield Road and Church End, Panfield  
Predicted Spend in 2016/17 - £52,000

LBRA152078 – Installation of a tactile crossing at the junction and improve the gradient, Newland Street j/w The Grove, Witham  
Predicted Spend in 2016/17 - £45,000

LBRA153006 – 1) Widening of the Northern refuge island, add tactile paving, replace bollards and add sign plates; 2) Excavate verge and lay new footway along Church Street; 3) Grove Field – Re-profile footway for addition of tactile paving (2 sites) and excavate verge and lay new footway; 4) Install new lining near Grove Field; 5) Install 2x VAS, A131 High Garrett, Braintree  
Predicted Spend in 2016/17 - £80,000

LBRA152019 – Installation of additional advanced warning '6.6 width restriction' sign and sub plate by the bench along Finchingfield Road; remove 'road narrow' sign and sub plate from BT pole in Church Street; install new post with 'road narrow' sign and sub plate and '6.6 width restriction' sign, Church Street, Steeple Bumpstead  
Predicted Spend in 2016/17 - £7,100

LBRA153001 – Installation of 46m of footway following existing f/w width from Ranulph Way past the property along Church Road known as Gables, back edging and up to the footpath with kerbing. The back edge to be soil and seeded. Optional - installation of three bollards to prevent vehicles mounting the kerb, Church Road, Hatfield Peverel  
Predicted Spend in 2016/17 - £51,800

LBRA152042 – Implementation of a 'one way' Traffic Regulation Order with the accompanying signs and lines for this section of Panfield Lane; a new 'no left turn ahead' sign prior to the junction and also a 'no entry' marking on the carriageway; new 'ahead arrows' to be installed on the carriageway, Panfield Lane between junction with Aetheric Road and Rayne Road, Braintree  
Predicted Spend in 2016/17 - £5,000

It was proposed also that the Panel should consider recommending further schemes having a total value of £220,000 for approval in order to create an £660,000 overall rolling programme. This would provide flexibility and ensure that the capital funding available for 2016/17 could be spent in full.

It was reported that the Panel's revenue budget for 2016/17 was £93,471 from which £70,000 would be allocated to work carried out by the Highway Rangers.

**DECISION:** That Braintree District Local Highways Panel's capital and revenue budgets for 2016/17 be noted.

## 6 **SCHEME UPDATE – B1018 BRAINTREE ROAD, CRESSING**

**INFORMATION:** Consideration was given to an updated report on the following scheme which had been approved for implementation.

LBRA142006 – Carriageway widening, installation of a footpath and new kerbing, B1018 Braintree Road, Cressing

Members of the Panel were reminded that the above-mentioned scheme had been recommended for approval by the Panel during the 2014/15 financial year at a cost of £200,000.

Completion of the scheme would require a section of land which was privately owned. However, the owner had indicated that the land was required as part of another development proposal for the area. Negotiations regarding this proposal were on-going and it was not known when the matter would be determined.

Discussions had taken place with Lambert Smith Hampton, Essex County Council's contractors for all land negotiations, who had suggested that there should be a combined approach in order to secure one solution to the development proposal and highway alterations. In the circumstances, it was proposed that scheme LBRA142006 should be put on hold. Furthermore, if

the scheme remained on the approved list a large proportion of the Panel's capital budget would continue to be re-profiled from one financial year to the next and would constrain the number of new schemes which could be commissioned during the 2016/17 financial year.

Whilst acknowledging the reasons for putting scheme LBRA142006 on hold, Members highlighted that it sought to improve a very dangerous stretch of road and that it should be brought forward for implementation if this was possible.

**DECISION:** That scheme LBRA142006 – carriageway widening, installation of a footpath and new kerbing, B1018 Braintree Road, Cressing be held in abeyance pending the outcome of negotiations and the determination of the development proposal currently being considered for the area, subject to the scheme being brought forward for implementation should this be feasible.

## 7 **SCHEMES FOR CONSIDERATION BY THE PANEL**

**INFORMATION:** Consideration was given to a report containing a schedule of possible schemes. The schemes recommended for approval would be put forward to be funded during the 2016/17 financial year.

In discussing this report, Members were reminded that the Panel's capital budget for 2016/17 had been fully allocated following the re-profiling of previously approved schemes. However, it was proposed that a rolling programme of schemes should be established to provide flexibility and to ensure that the 2016/17 budget would be spent in full.

### **DECISION:**

- (1) That the following schemes be recommended for approval, subject to the specific comments denoted:-

#### Passenger Transport

LBRA165001 – Replacement of old metal bus shelter with wooden shelter, removal of flag from lighting column, make up new and attach to new shelter, 3901702, Allectus Way, Witham  
Estimated Cost - £8,500

LBRA165004 – Installation of new wooden shelter on verge, 27011012, Colchester Road near the junction of Normandy Way, Bures  
Estimated Cost - £8,000

### Public Rights of Way

Blade the footpath level, install a sub-base and drainage and cap with a suitable all-weather surface, from the River Blackwater Northwards to the concrete track from Convent Lane carrying Footpath 37, Footpath 52, Braintree

Estimated Cost - £10,000

(This scheme was reported verbally to the meeting).

### Safer Roads

LBRA161001 – Installation of an indicative right turn phase for motorists travelling south, including the installation of an additional right turn signal head on the existing signals at the South-Western corner of the junction, crossroads at The Avenue j/w Newland Street, Witham  
Estimated Cost - £25,000

LBRA161002 - The kerbs to be built out and relocation of the central island/dome to a more central position, A1124, 100 yards South of Church Hill, Earls Colne  
Estimated Cost - £18,000

LBRA161003 - Study to ascertain if the junction may be reconfigured to a normal junction to replace the existing Bennett junction, B1018 Witham Road, j/w Temple Lane, Silver End  
Estimated Cost - £5,000

LBRA161004 – Relocation of existing advanced 'give way' signage to 100 yards from the junction, replacement of the existing junction and reconfiguration to a normal junction, Halstead Road, j/w Queen Street (Braintree Corner), Sible Hedingham  
Estimated Cost - £10,000

LBRA161005 – Installation of improved signage for the national cycle way and cycle warning signage, review the location of the bus stop, painting of bus cage marking on the carriageway and relocation of the existing telegraph pole within the visibility splay for Godlings Way to the back of the footway, London Road, j/w Godlings Way, Braintree  
Estimated Cost - £16,000

LBRA161006 – Provision of new zebrite belisha beacons, complete a scrim survey to ascertain the extent of the below standard surfacing, provision of a 'pedestrian crossing' warning sign on the North-bound approach, refresh the 'crossing carpet' and approach 'zig zag' markings and provision of 'slow' road markings adjacent to the new advanced signage, Maldon Road, approx. 100 metres North of j/w Blackman Way, Witham  
Estimated Cost - £11,000

LBRA161007 – Provision of build out or over-run area on the Northern side, relocation of existing illuminated sign to the build out and 'no entry' road markings to be applied to the carriageway surface at the junction mouth, High Street, near to The Boars Head 20 yards from j/w St Michael's Road, Braintree  
Estimated Cost - £10,000

#### Traffic Management

LBRA162001 – Installation of 'unsuitable for motor vehicles' signs on London Road and Bakers Lane to prevent vehicles mistakenly using Pickpocket Lane, Pickpocket Lane, Black Notley  
Estimated Cost - £4,000

LBRA162003 – Relocation of the existing blue 'width restriction' sign along The Grove and upgrade to a larger sign, The Grove, j/w Pasture Road, Witham  
Estimated Cost - £3,000

LBRA162005 - To carry out informal consultation on amending the single yellow line restriction on the South side of Chipping Hill from its junction with Earlsmead Westwards for a distance of approximately 200 metres to Bridge House. This can be changed to 'No Waiting 7am-7pm' during bus operational hours, Chipping Hill, Witham  
Estimated Cost - £1,500

LBRA162006 – Installation of tactile crossing point where alleyway from Collingwood Road emerges onto Guithavon Valley and on opposite side of the road; extend the existing double yellow lines to cover the new crossing point. Installation of a tactile crossing at the junction with Almond Road, Guithavon Valley, Witham  
Estimated Cost - £14,000

LBRA162009 – Installation of a VAS/SID along Swan Street at the entrance to the village, Swan Street, Sible Hedingham  
Estimated Cost - £8,500

LBRA162011 – Installation of three guard rails set back from the carriageway to aid the safety of pedestrians at the crossing patrol, John Ray Junior School, Notley Road, Braintree  
Estimated Cost - £6,000

LBRA162012 – Removal of the 'reduce speed now' sub plate on both approaches and installation of 'on-coming vehicles in middle of the road' (TSRGD Diag No. 575) plate, North End Road, Little Yeldham  
Estimated Cost - £1,500

LBRA162013 – Installation of two 'pedestrians in road' signs at approach to the humpback bridge in both directions, Maldon Road j/w Ewell Hall Chase, Kelvedon  
Estimated Cost - £3,000

LBRA162014 - To investigate the possible provision of additional parking bays along Guithavon Valley and to carry out a safety audit. To investigate if a tactile crossing point can be installed at the junction with Collingwood Road, Guithavon Valley, Witham  
Estimated Cost - £4,000

LBRA162015 - Feasibility study for the installation of a zebra/signalised crossing, Crossing Road, South of Stubbs Lane, Braintree  
Estimated Cost - £10,000

LBRA162016 - Installation of a tactile crossing at Francis Way j/w Broadway and improvement to drainage due to ponding in the vicinity of the crossing. Installation of a tactile crossing adjacent to the shops/library, Francis Way j/w Broadway, Silver End  
Estimated Cost - £10,000

(It was agreed that the cost of this scheme should be reduced by omitting the proposed tactile crossing adjacent to the shops/library and that the revised scheme should be agreed with the Chairman of the Panel)

**DECISION:** That the programme of schemes recommended for approval at previous meetings of the Panel be noted.

### 9 **DATES OF NEXT MEETINGS OF THE PANEL**

**INFORMATION:** Consideration was given to a schedule of dates for forthcoming meetings of Braintree District Local Highways Panel.

In discussing this item, Councillor Mitchell pointed out that as well as representing Braintree District Council on the Local Highways Panel he also represented the District Council on the North Essex Parking Partnership. As such, Councillor Mitchell considered it important that he should attend meetings of the Panel on a regular basis, but due to changes in work commitments this may not be possible. In the circumstances, Councillor Mitchell requested that the dates for future meetings of the Panel should be held in abeyance.

**DECISION:** It was noted that the next meetings of Braintree District Local Highways Panel were proposed to take place on 7th July 2016, 22nd September 2016 and 19th January 2017.

The meeting commenced at 6.00pm and closed at 8.00pm.
