1. Apologies

Councillor Whitehead welcomed everyone present. Hannah Neve (Essex County Council) had sent her apologies.

2. Minutes of the Chelmsford Local Highways Panel Meeting on 6 November 2013

The minutes of the Chelmsford Local Highways Panel meeting held on 6 November 2013 were approved as a correct record and signed by the Chairman. County Councillor Mackrory asked for and received confirmation that in Minute 3 the funding re-allocated from the design work in New Nabbotts Way, which would not now be required, would be used for to consider other traffic reduction measures in the vicinity.

3. Matters Arising

Jon Simmons reported that under Minute 4 the Panel had indicated that they wished to agree funding of up to £5,000 for feasibility schemes in advance. He had been advised subsequently that this was not possible and all such decisions needed to be taken on a case by case basis by the Panel.

County Councillor Johnson confirmed that this had also been confirmed to the Harlow Local Highways Panel.

Jon Simmons also confirmed that delays had occurred with the Odeon Roundabout scheme as three firms were considering the target costings. In answer to a question form County Councillor Madden, he reported that the Section 106 scheme at Goldlay Avenue would be linked to the current Parkway widening and be following on from it rather than being carried out at the same time.

The Chairman asked that a report on the scheme be made to the next meeting.

On Minute 6(1), the Chairman reported that the Navigation Road scheme had been delayed in order that a one-way scheme could be considered. In answer to a question from County Councillor Mackrory, he explained that the one-way proposal was only a draft suggestion at present but was in line with discussions held at a Chelmsford City Council meeting in 2013. He understood that Essex County Council was considering the aggregate effect of a number of developments in the vicinity. It would be discussed at a meeting between Chelmsford City Council and Essex County Council and further information would be provided to Members in due course. Joy Thomas confirmed that Section 106 funding for Navigation Road was secure with ECC.

On Minute 6(2), in answer to a question by County Councillor Mackrory, Jon Simmons confirmed that both schemes DC 29 (Pump Lane/Springfield Road, Springfield – design of road widening) and DC1120 Stump Lane – pedestrian refuge island) had been completed.

Jon Simmons reported that Hannah Neve had hoped to have been able to report to this meeting on the Colchester Road widening (Drovers Way to Boreham) as requested in Minute 7. As she was unable to attend the meeting, the report would be sent out with these minutes and would be considered at the next meeting.

Under Minute 8, Jon Simmons had been asked for information about the angle at which the flails are set for hedge trimming and he had now been advised by the Highways Rangers that the angle varied depending on the local features of the verge. Highways Maintenance and Passenger Transport had however recently used an adapted bus to cut hedges overhanging vegetation on bus routes and if Councillors were aware of particular problems, he asked that they notify him and he would ask colleagues to investigate.

ACTION:

- (a) An update report on the Parkway widening and Odeon Roundabout schemes be provided at the next meeting;
- (b) The report 'Colchester Road widening (Drovers Way to Boreham)' be provided with these minutes and considered at the next meeting

4. Approved Work Programme

The Panel considered the approved scheme list for 2012/2013 and 2013/2014. The following items were brought to the Panel's attention.

(1) Vehicle Activated Sign (VAS) Schemes

Schemes 19, 20, 27, 34, 54 and 67 had been recommended for funding by the Panel

at previous meetings and they had now undergone a speed survey as part of the design process. The six sites had not met the criterion that average speed should be at least 5 mph over the speed limit for a VAS to be considered. The Panel considered scheme 19 for Gloucester Avenue and noted that average speed was only slightly higher than the 30 mph limit. It was agreed that these schemes should not be supported for progression and that monies designated for the schemes should be reallocated but that clarification of the VAS/Speed Management Policy should be presented at the next meeting.

Scheme 101 for Casualty Reduction required a top up of £5,000 and the Panel agreed to that additional funding.

5. Potential Scheme Proposals

The Panel received a report on potential scheme proposals, which had been prioritised against set criteria and given a red, amber or green status showing its priority.

The Panel had a revised 2013/14 capital budget of £400,700 and had to date made recommendations of £237,900, leaving £162,800 for other schemes. In addition, the Panel had a revenue budget of £129,000 less estimated Highways Rangers' costs of £84,000 and recommended expenditure of £16,300, leaving £28,700 remaining for pre-construction feasibility/design/survey works. In answer to a question by the Chairman about whether once a feasibility study had confirmed that construction can go ahead, whether that revenue expenditure could become capital expenditure, Erwin Deppe explained that for major schemes, this would not be possible and that with these schemes such a transfer was also unlikely.

Councillor Shepherd explained the background to LCHE132086 (Paper Mill Bridge, North Hill and j/w Moden Hall Lane, Little Baddow) and LCHE132085 (Hammonds Road, Little Baddow and Church Road, Boreham) and emphasised that the flood warning improvements were essential.

County Councillor Aldridge explained the background to scheme LCHE132076 and LCHE132073 (Ongar Road/Lordship Road, near Doctors' surgery, Writtle). He considered that whilst a scheme was essential, the proposal needed to be made larger and more enhanced as other measures were required. Jon Simmons agreed to contact the Parish Council to receive further information. Joy Thomas also confirmed that there was in the region of £36,000 Section 106 funding available for a possible scheme in this location.

County Councillor Hume commented on the strength of local support for the removal of speed humps as part of scheme LCHE132050 (King Edwards Road, South Woodham Ferrers) to facilitate the provisions of a bus service. It was noted that the road humps could be removed so that the impact on speeds could be assessed and this was agreed.

Jon Simmons referred to the fact that scheme LCHE132060 (Viaduct Road, Chelmsford) was currently "red" because consultations were required with British Rail and the South Essex Parking Partnership. Rosa Tanfield confirmed that South Essex Parking Partnership were in discussion with British Rail and local traders.

County Councillor Mackrory asked about the difference between scheme LCHE132050 (King Edwards Road, South Woodham Ferrers) and scheme LCHE132054 (Lawn Lane. Springfield), which was a "red" scheme and with regard to the consistency of validation. Jon Simmons advised that the Springfield scheme related to the validation of the effect on speed of the pre-formed humps which had replaced the tarmac ones. The Panel agreed that the scheme could be re-instated to assess the design of the humps.

County Councillor Mackrory also asked about scheme LCHE132077 (New Bowers Way, White Hart Lane, Springfield) which related to improved signage for the Library and Parish Council. It was noted that the scheme was against signing policy and it was agreed that this matter be considered further and a report be made to the next meeting of the Panel,

ACTION

Jon Simmons to report on signing policy to the next meeting of the Panel.

6. <u>Highways Improvement Scheme Proposals</u>

The Panel considered a report on highway improvement schemes under various headings. It was noted that schemes requiring speed surveys previously agreed and noted earlier in the meeting under Approved Works Programme 'Speed Survey' were complete but that validation was on-going. Scheme IT134 (Broomfield Road and Patching Hall Lane/ Broomfield Parade, Chelmsford) was awaiting validation of the parking issues along Broomfield Parade. The design costs of schemes LCHE135013 (Nabbott Road, Chelmsford) and LCHE135014 (Cross Keys, A1060, Boyton Cross) both at £1,500 were agreed. The other schemes were progressing.

In answer to a question by Councillor Grundy, Jon Simons confirmed that the Parish Councils affected by schemes LCHE 132075 (Margaretting Road/ Writtle Road, Writtle) under potential schemes and LCHE 132059 (B1002 Main Road, Wantz Road/Writtle Road, Margaretting) had received details of the speed surveys

7. Highways Rangers Summary

Jon Simmons circulated an updated summary of the Chelmsford City Highways Rangers work programme. County Councillor Mackrory asked for details of the criteria for cutting back vegetation in view of problems experienced in Stump Lane, Chelmsford. Jon Simmons explained that unless there was a safety issue, the maintenance section would pursue with the landowner first but he agreed to raise this matter with the maintenance team himself.

ACTION

Jon Simmons to raise this issue of the delay in cutting back vegetation along routes with the maintenance team.

8. Any Other Business

(1) Tour de France

County Councillor Aldridge asked for clarification of the advance maintenance of the route to be used by the cyclists in the Tour de France. Jon Simmons confirmed that the Maintenance Team would minimise the disturbance to the route prior to the event. Averil Price asked that the Local Chelmsford Delivery Group be linked with the County Council Group to achieve a co-ordinated approach.

ACTION

Jon Simmons to provide Averil Price with details of the link between the Local Chelmsford Delivery Group and the County Council Group.

(2) Proposed Schemes

County Councillor Johnson commented that if local Councillors believe a scheme is a necessity and will make genuine improvements, they should pursue it even if it conflicts with general policies. The Chairman confirmed that as the Panel were resolving the earlier backlog of schemes, the possibility of setting a more defined direction would become feasible.

(3) Speed Watch

Councillor Grundy asked about the procedures involved with speed watch signs and which agency was responsible.

ACTION

Jon Simmons to report on these arrangements to the next meeting.

(4) Margaretting Road, Galleywood

The Chairman asked that scheme Margaretting Road, Galleywood (DC1321), shown on the Approved Programme of Works, for the continuation of the footway from the Village to the Heritage Centre be brought forward into 2013/2014 so that it can be tied with the existing flood alleviation scheme.

ACTION

Jon Simmons undertook to discuss this with the Delivery Team and provide a progress report at the next meeting

(5) Next Meeting

AGREED that a meeting be arranged for 24 February, 2014 at 12:30 p.m.

Town and Country Planning Act 1990 – Section 106 Agreements. "Springfield Pot" Contributions.

Potential Colchester Road Widening.

The meeting of the panel on 6th November 2013 considered a report (agenda item 7) regarding section 106 income for highways and transportation purposes in general and made reference to contributions accrued as a result of the Springfield Area Traffic Impact Study (SATIS) of 1996; the "Springfield Pot". The study was commissioned jointly by Essex County Council and Chelmsford Borough Council to assess the cumulative traffic impact of the two major residential and two major employment sites designated in north east Chelmsford in the Chelmsford Borough Council Local Plan (adopted in1997). The residential schemes at Beaulieu Park and Chancellor Park are complete with all contributions received but the two employment sites at Chelmsford Business Park (formally Springfield Lyons) and Springfield Business Park continue to be developed with contributions still to be received.

The "Pot" has delivered many items of new transport infrastructure in the North East quadrant of Chelmsford, continues to accrue (in both capital receipts from ongoing development and interest terms) and currently contains some £607,000. This total sum is held jointly by both Essex County Council and Chelmsford City Council.

However there are some schemes still to be funded by the Pot as discussed below.

Outstanding Commitments

The Pot has been drawn down to fund many improvements in north east Chelmsford over the last 10 years or so but there are two outstanding Toucan crossing (joint pedestrian/cycle use) projects to be progressed, classified as commitments:

Chelmer Village Way – provision of a Toucan crossing at the junction with Brook End Road North. This facility is a fundamental part of and essential for the integration of the development of Chancellor Park into Chelmer Village. The crossing also fills a gap in the local and wider cycle network and serves a strong journey to school route - estimated cost £200,000.

Chelmer Village Way – provision of a Toucan crossing at the north end of Barlows Reach to enable continuity of cycle routes through the area and pedestrian access to public transport and recreational area (public open space)

east of Chelmer Village Way. A continuous cycle/pedestrian facility through Chelmsford Business Park will be completed creating further demand for a crossing facility of the high speed Chelmer Village Way at this point. Some minor preparatory works have been completed with adjacent development - estimated cost £150,000.

Further Project

Springfield Road – provision of a Toucan crossing in the vicinity of Pump Lane/Oasis Court. This is a proposal which would greatly assist cyclists and pedestrians negotiating this section of high speed dual carriageway. The Springfield Road junction with Pump Lane and the A138 northbound on slip road has recently been modified to rationalise and clarify turning movements. The crossing facility would greatly assist pedestrian and cycle permeability between North Springfield/Beaulieu Park and Dukes Park/Chelmer Village - estimated cost £180,000. The LHP have allocated funding for a feasibility study for this scheme.

If all three of these schemes were to be completed the Pot balance is reduced by some £530,000, to £77,000, and this more accurately reflects the true current level of funding available for any other proposals from the Pot.

Future Receipts

The development of the Chelmsford Borough Local Plan (1997) employment land allocations is still progressing and there are still some contributions to be received. Recent permissions and outstanding payments total some £438,000.

A130 Colchester Road

A possible improvement considered as part of SATIS to deal with projected traffic increases in north east Chelmsford as a result of the 1997 Local Plan designations was an increase in capacity on Colchester Road between Drovers Way and White Hart Lane. The project was not considered to be cost beneficial at the time and was not included as part of the overall conclusions and formula calculations.

However, on-going general observations and experience indicate that the existing width of A130 Colchester Road appears to be an impediment to traffic flow particularly westbound from the A12 northbound off slip road approaching White Hart Lane. The known difficulties experienced on this link have been considered during the preparation and examination in public of the North Chelmsford Area Action Plan but it has not been identified for improvement to support the provision of new housing and employment provision in North East Chelmsford in the current Local Development Framework. When the approved housing schemes in north east Chelmsford reach 1000 units a new Radial

Distributor Road will have been provided around the housing which effectively will bypass A130 Colchester Road and White Hart Lane as a new A130. However this is unlikely to be available for use for several years, 2018 at the earliest which depends on a considerably accelerated rate of house building. Presently the delays experienced on A130 Colchester Road take place throughout the day and obstruct the ability of drivers to access the business areas of Chelmsford Business Park and Dukes Park.

For some time officers have been exploring a design and cost appraisal for an improvement scheme which it is considered may assist in managing the traffic volume/demand in this corridor.

The scheme essentially creates a second lane on the westbound approach to the Sainsbury roundabout. Drivers would then have the opportunity to queue in two lanes to make the right turn into White Hart Lane thus simplistically halving the queue. This would clearly assist drivers who are intending to reach the business areas. If this objective proves to be unsuccessful due to driver reluctance to complete this double right turn manoeuvre then a further effect would be that drivers heading straight on towards the business parks, in the nearside lane, would be afforded a clear run to the junction separated from the northbound and Sainsbury's bound (right turning) traffic, in the offside lane.

The work that has been completed so far results in the following cost breakdown:

Estimated Costs

£810,000

Total cost so far: £1,874,600

Costs not included (not yet investigated)

- 1. Potential design for a northbound two lane exit from the Sainsbury's roundabout to White Hart Lane if required.
- 2. Redesign of the existing Toucan crossing on A130 Colchester Road to the front of the BMW car dealership.

Work on this project is suspended due to other priorities and the doubt over the deliverability due to the above cost indications.

Other Sources of Funding

Local

The original SATIS based fund (the Springfield Pot) has been added to by further development opportunities coming forward, outside the SATIS remit, in north east Chelmsford. This approach enables obligations from new planning permissions to be delivered holistically through the Pot for the benefit of north east Chelmsford. This on-going position will be maintained.

Community Infrastructure Levy

This new national levy (CIL) is due to be implemented in April 2014 (more realistically June 2014). There may be opportunities for securing some funding from this source although realistically this is unlikely due to the high demand for a host of other infrastructure.

Pinch Point Programme

A recent government initiative is a national "Pinch Point Fund" designed to identify locations on the transport network which are considered to be restrictions to growth and prosperity. The difficulties encountered by drivers on the A130 Colchester Road are considered to fit the general aspirations for pinch point funding. A scheme for A1060 Parkway has been the subject of a successful bid this year from the pinch point fund. A further scheme for A1060 Parkway is currently the subject of a bid. As the Springfield Pot is unlikely to match the costs of a widening scheme, A130 Colchester Road could be a further scheme subject to a pinch point funding bid.

Conclusions

- 1) The current balance of the Pot is £77,000 if the three crossing projects outlined above are completed.
- 2) Further known contributions could increase this figure to £515,000 at an undetermined point in the future. Clearly if any of the crossing projects do not proceed then the current balance of the Pot is accordingly increased.
- 3) Whilst the Springfield Pot has been influential in delivering a host of "soft" mitigation measures for dealing with traffic issues in north east Chelmsford it is clear that the increasing costs of highway works (often due mainly to utility diversions) results in the likelihood that the Pot will be unable to match the costs of the A130 Colchester Road project. Such a major piece of infrastructure improvement would require considerable top up funding.

4) Committing the remaining balance of the Pot to the A130 Colchester Road project would remove the ability of the Pot to respond to any other identified north east Chemsford related transport issue.

Summary

The Local Highway Panel requested this report for information. The Panel is asked to express a view on the A130 Colchester Road improvement proposal.

Chelmsford City Local Highways Panel

Potential Scheme Proposals

The attached report details those new schemes brought forward for the consideration of the Panel. Each scheme has been prioritised against set criteria and given a RAG status, showing its priority.

The Chelmsford City Local Highways Panel has a revised 2013/14 Capital budget of £400,700 and currently the Panel have made recommendations from this totalling £319,150 with £81,550 remaining for the implementation of schemes.

In addition the Panel has a 2013/14 revenue Budget of £129,000, with an estimated Highway rangers cost of £84,000. The Panel has made recommendations from this totalling £42,260 with £2,740 remaining for pre-construction feasibility/design/survey works.

There is below a summary of the schemes currently on the Potentials Schemes List.

Schemes 1, 3, 4, 5, 7, 9, 10, 11, 13, 14, 17, 18, 19, 23, 24, 31 and 33 are shown as "greyed" out, as the Panel made these recommendations at the Last Panel meeting. These schemes have been signed off and will now transfer onto the Approved Works Programme/Highway Improvement Scheme List, where appropriate.

Schemes 2, 6, 8, 12, 15, 16, 22, 26, 27, 28, and 29 are pending the results of the validation process. In addition scheme 21 is being re-assessed following the submission by the Town Council of additional supporting evidence.

Chelmsford City Local Highways Panel

Highway Improvements Scheme Proposals

The attached report details those highway improvement schemes brought forward for the consideration of the Panel. Each scheme has been prioritised against set criteria and given a RAG status, showing its priority.

The Chelmsford City Local Highways Panel has a revised 2013/14 Capital Budget of £400,700 and currently the Panel have made recommendations of £319,150 with £81,550 remaining for construction of schemes.

In addition the Panel has a 2013/14 Revenue Budget of £129,000, with estimated Rangers costs of £84,000 and the Panel has made recommendations from this of £42,260 with £2,740 remaining for pre-construction feasibility/design/survey works.

There is a summary below of the Highway Improvements Schemes List, currently traffic surveys have been carried out on proposed schemes 1, 2, 4, 5, 6, 7, 8, 9, 10 and 12. The speed/volume data is being used in the Validation process to assess the feasibility of the proposals. The results of the Validation will be reported to a future Panel meeting.

The Bus Stop Improvement Schemes 2 and 3 are shown as "Greyed" out, as the Panel agreed to fund them at the last Panel meeting. These schemes have been signed off and will now transfer onto the Approved Works Programme.

There is a request to fund two speed/volume surveys for Scheme 11, at a cost of £420 from the Revenue Budget, to assist the Validation of the proposal.
