

The existing retail site on the Bull Hill Industrial Estate is due to be demolished in early 2016. Demolition works of the existing Co-op store and the surrounding retail units is scheduled to commence in January 2016, with construction of the new store programmed to start in April 2016.

The project has been awarded to ISG by Asda and we will be managing the site as main contractor from commencement of demolition, until handover of the new Asda store.
