1. ELECTION OF CHAIRMAN/DEPUTY CHAIRMAN FOR 2016/17

4. EPPING FOREST LHP 2016-17 SUMMARY

The Chairman, and Local Highway Panel (LHP) were advised by the Highways Liaison Officer (HLO) of the present value of the scheme in light of the decisions taken at the Essex County Council meeting, held on Tuesday 9th February 2016.

5. SCHEME RECOMMENDATIONS

The Chairman, HLO, and Local Highway Panel Members considered which potential schemes should remain or be removed from the list for consideration within the 2017/18 financial year.

(1) Cycling

Item 1 – St. Leonards Road/Nazeing Road/North Street/Middle Street; highway widening project to be re-examined by the ECC Road Safety Team to determine requirement. Conclusions will be present to LHP at subsequent meeting.

(5) School Crossing Patrol

No Change.

(6) Traffic Management

Item 10 – Laundry Lane; no through road or install lockable gate; after discussion it was agreed that this project would be re-examined by ECC Highways to determine feasibility. This would include a survey of traffic flow along the aforementioned road. To be progressed.

Item 13 – B181 Lindsey Street, Epping; after discussion it was agreed that this project would be re-examined to determine feasibility. To be progressed.

Item 15 – Stonards Hill, Epping; speed reduction and traffic calming measures. After discussion it was agreed that this project would be removed from the potential schemes list.

Item 18 — Walton Gardens, Waltham Abbey; to improve the radius and width of the road to enable vehicles to not mount the kerb. Ownership of bordering land to be established. To be progressed.

Item 19 – Parklands, Waltham Abbey; improve crossing facilities and traffic calming measures. After discussion it was agreed that this project would be removed from the potential schemes list.

Item 21 – Bell Common, Epping; implement traffic calming measures. After discussion it was agreed that this project would be removed from the potential schemes list.

Item 22 – Highfield Place j/w B1393 High Road, Epping; install keep clear markings. After discussion it was agreed that this project would be removed from the potential schemes list.

Item 23 – Kendal Avenue, Epping; traffic calming measures. After discussion it was agreed that this project would be re-examined to determine feasibility, as the required traffic survey was wrongly sited. To be progressed.

(7) Quiet Lanes

Clays Lane, Loughton; Implement Quiet Lane; after discussion it was agreed that this project would be removed from the potential schemes list. To be progressed.

6. INDICATIVE PROGRAMME LIST

The HLO advised members of the Highway Panel on the schemes approved and delivered from 2012/13 to 2015/16.

(1) Traffic Management

Item 1 – Crooked Mile, Waltham Abbey; signal controlled crossing. The HLO informed members that one factor to the delays in the implementation of this scheme were due to the absence of a required project manager, and that the anticipated start date would now be Tuesday 30th August 2016. The duration of this project would be six to eight weeks.

Item 2 – Vicarage Lane j/w Manor Road, Chigwell. The HLO updated members on the present situation. The anticipated start date would now be Monday 11th July 2016, whilst the duration of this project would be approximately eleven days.

Item 31 – B181/Upland, Epping Upland. After discussion the HLO advised members that he would look to see if the feasibility study would be made available for completion this financial year.

8. ANY OTHER BUSINESS

(1) Theydon Bois Finger Sign Post Maintenance

The HLO advised the Panel that the previously suggested Finger sign-post maintenance project would require the requisite insurance arrangements in order to progress. This requirement will be considered by the respective representatives, and a response given in due course.

(2) Passenger Transport

The Chairman advised the Panel that the investigation into the feasibility of a 'Hail & ride' scheme being introduced was progressing, and engagement with the respective authorities continues. The Panel would be advised of any outcomes at the following LHP meeting.

(3) Budgetary Matters

After discussion the Chairman expressed concerns of the absence of accountability from private contractors employed on behalf of ECC Highways to undertake the approved schemes. This concern was reiterated by members, and after further discussion it was agreed that Panel representatives of ECC Highways would investigate the feasibility of more transparency with respect to how the allocated budget is calculated for suggested, as well as approved schemes.
