The Validation is an initial, brief assessment of the scheme, options for next steps and provisional cost estimates for the Braintree Local Highways Panel to consider for funding.

The validation will also assess whether the scheme request meets current implementation guidelines and satisfies ECC policy requirements. For some requests, a pre-validation survey is required.

REPORT - Deanery Hill, Braintree - LBRA142060

The Deanery Hill scheme was recommended at the June LHP meeting with a caveat regarding the fibre optics and the possible increase to the delivery cost.

The BT Fibre Optics have been identified during the design stage with the diversion cost to exceed £78,000 and the deliver cost expected to increase by an additional £20,000. This is a total delivery cost of around £98,000.

A decision on whether the scheme proceeds needs to be decided by the LHP Members. If the top up is to be agreed, the scheme will be programmed for delivery during the 2015/16 financial year.

REPORT - Bramble Road, Witham – LBRA132039

The Bramble Road, Witham scheme was recommended by the Braintree LHP Members for 'Design Only' at the January meeting within the 2013-14 financial year.

The scheme was to look at re-profile the kerb line at the junction of Flora Road / Bramble Road to tighten up the turning movement and reduce the speed of vehicles entering the junction. To install priority working along Bramble Road to the northeast of Harebell Drive.

I have been in contact with an Essex County Council Officer who has informed me that this scheme can be delivered with the initial £32,000 S106 funding and will no longer need additional funding from the Braintree LHP.

REPORT - Inworth Road, Feering (LBRA003001)

During the 2012/13 financial year the Braintree Local Highways Panel (LHP) Members recommended £130,000 toward the extension of the existing footway along the eastern side of Inworth Road.

A report was presented at the LHP meeting in October 2013 regarding the delay to the delivery due to a number of residents withdrawing their consent and that the complete length of footway was now unable to be constructed. The reasoning behind this was because residents were concerned about the Site Allocations and Development Management Plan. Braintree District Council are currently preparing a new Local Plan.

At the October 2013 meeting it was reported that a £31,000 contribution from Section 106 towards the delivery of the scheme and a small fee of £20,000 from the LHP would be needed to deliver the sections that had support from residents. This resulted in the approval of those lengths only being built.

As a section of the approved scheme has already been implemented, any decision to proceed with the rest of the scheme will need to be the subject of a formal recommendation from the Braintree LHP. That proposal will need to be justified on a stand-alone basis and finance will need to be secured against its implementation. Unless agreement can be reached with all the landowners concerned to make the land available a compulsory purchase order will need to be made. It therefore needs to be established whether those who previously were against the construction of a footway across their frontage remain of that view and a recommendation needed to proceed with the missing section of footway. That is why any use of compulsory powers to secure the scheme must be justified on merit.

With the highway land that needs acquiring from residents in order to complete the rest of the footway, the question to the Braintree LHP Members is therefore do you unanimously recommend that the highway authority continue with further investigation works in respect of the unconstructed section of footway with a view to authorising the use of compulsory purchase powers should that prove to be required.


