BRAINTREE DISTRICT COUNCIL WITH ESSEX COUNTY COUNCIL LOCAL HIGHWAY PANEL – 25th JUNE 2015 2015/16 POTENTIAL CAPITAL SCHEMES

From the schemes recommendations made by the Panel in 2014/15 there were schemes to the value of £356,000 which have been re-profiled and are being delivered in 2015/16. It is considered prudent for the Panel to make further recommendations against the 2015/16 Capital Budget of £815,578. Thus far this financial year the Panel has recommended £416,950, which leaves a remaining £398,628 to be recommended.

This will ensure a recommended 2015/16 Capital Budget of £1,171,578 and will allow for the development of the rolling programme into 2016/17.

The following list identifies all of the scheme requests which have fed into the Braintree LHP. The RAG column acknowledges what the status of the scheme request is as below:



= The scheme has been validated as being feasible and is available for consideration.



= The scheme has previously been approved for a feasibility study and the results are awaited before the scheme can be fully considered.



= The scheme request is against ECC criteria.

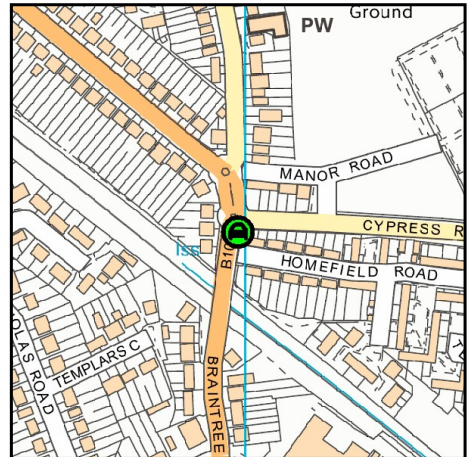

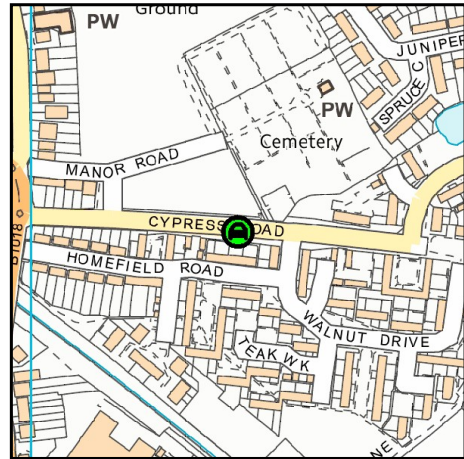
