1.	Welcome: Councillor C Siddall, Chairman, welcomed all attendees to the meeting and he invited everyone to introduce themselves. For the information of members of the public who were in attendance at the meeting, Councillor Siddall outlined the process which was followed for submitting proposed highway improvement schemes to Braintree Local Highways Panel, how these were processed; and the ability of the Panel and Essex County Council's Cabinet Member for Highways, Infrastructure and Sustainable Transport to approve such schemes.	
2.	Apologies for Absence, Declarations of Interest and Public Questions: Apologies for Absence:	



Apologies for absence were received from Councillor J Ayten (BDC), Councillor K Barnes (BALC), Councillor T Cunningham (ECC), Councillor D Louis (ECC), Councillor R Playle (ECC), and Councillor G Spray (BDC).

An apology for absence was also received from Lisa Hinman, Area Manager (North Essex Parking Partnership)

Declarations of Interest:

There were no interests declared.

Public Questions:

The meeting was not held in public, but Councillor Siddall, the Chairman, allowed Mr A Panton, Mr D Price and Mr P Ridley to each make a statement, the details of which are summarised below.

Statements by Mr A Panton, Mr D Price and Mr P Ridley

Messrs Panton, Price and Ridley referred to problems associated with the use of Bulford Mill Lane, Cressing, which was a narrow, bending lane situated between Cressing and Black Notley. In particular, reference was made to the increased use of the lane by vehicles and HGVs trying to avoid traffic congestion on the A120 at Galleys Corner roundabout, Braintree and use by residents of new housing developments recently constructed nearby.

It was reported that vehicles sometimes became stuck in the lane and had to be recovered. There had also been a number of accidents along the lane, and it was often difficult for emergency vehicles to gain access. The lane was also subject to flooding, drainage channels had become blocked, and the condition of the lane was deteriorating. Although there was not a footpath along the lane, it was used by pedestrians, particularly people walking to and from Cressing railway station, which posed a danger.

It was stated that the issues affecting the lane had been discussed for many years, but nothing had been done to rectify the situation. Messrs Panton, Price and Ridley asked Members of Braintree Local Highways Panel to support scheme LBRA242020 - Traffic calming measures at Bulford Mill Lane, Cressing, which had been submitted for consideration by the Panel. Members of the Panel noted that this scheme had been validated, but that it had been categorised as 'red'. Essex Highways' Design Team had concluded that there was nothing that could be done from an engineering perspective to improve



the condition of the lane and they had recommended that the proposed scheme should not be taken further.

Whilst Members of the Panel sympathised with residents of the lane, it was acknowledged that the Panel had limited resources, that its decisions had to be based on guidance and data, and that funding was limited. It was noted that some small scale improvements had already been implemented in the lane. It was also reported that a reduction in the speed limit would not necessarily provide a solution, that people should drive according to the conditions of the road, and that it was for the Police to enforce use of the highway. Furthermore, it was noted that flooding issues and the erosion of kerbs were maintenance matters, which were outside the scope of the Panel. However, it was possible that funding was available to deal with flooding. In addition, it was reported that matters falling outside the remit of the Panel could be referred to Essex County Council's Cabinet Member for Highways, Infrastructure and Sustainable Transport.

The Chairman thanked Messrs Panton, Price and Ridley for attending the meeting and he indicated that he would pursue the matter on their behalf and discuss it with Essex County Council's Cabinet Member for Highways, Infrastructure and Sustainable Transport.

Messrs Panton, Price and Ridley left the meeting at this point together with other members of the public, who had attended to observe.

3. | Minutes:

The Minutes of the meeting of Braintree Local Highways Panel held on 29th August 2024 were approved as a correct record and signed by the Chairman.

4. Matters Arising from the Minutes of the Meeting Held on 29th August 2024:

Dan Maclean, Essex Highways, provided an update on matters which had been raised at the last meeting.

Particular reference was made to one matter and the following update was provided: -

Minute 4 - Matters Arising from the Minutes of the meeting held on 29th April 2024 (Minute 5 - 'Funded Schemes 2023/24)

LBRA162029 – 'Quiet Lane', Water Lane, Shalford Estimated Cost: - £1,250



It had been reported, that although this scheme had been completed, it was unlikely to allay the concerns of local residents about the use of the lane. The lane was a single track with a 60mph speed limit, and it was used as a 'rat run' if there was traffic congestion elsewhere.

Dan Maclean, Essex Highways, had been asked to review the scheme to determine if anything could be done to alleviate the issues affecting the lane and he had spoken to Officers within Essex Highways' Design Team who had suggested that a speed and volume survey could be carried out to ascertain whether the 'Quiet Lane' status of Water Lane was relevant. Members of the Panel had agreed that the speed and volume survey should be carried out.

<u>Update</u>: - Dan Maclean, Essex Highways, reported that the speed and volume survey had not been carried out yet. In discussing this issue, Members of the Panel were advised that the 'Quiet lane' status of Water Lane, Shalford could be used as an example to illustrate the effectiveness of 'Quiet lanes'.

Dan Maclean, Essex Highways, reported that steps had been taken to implement all other action points referred to in the Minutes of 29th August 2024.

5. Funded Schemes 2024/25:

Consideration was given to a report on the Panel's Funded Schemes for 2024/25, which had been recommended for approval. The report provided an update on the current position of all schemes in the 2024/25 programme of work.

Members of the Panel were advised that funding of £203,894 had been allocated to Braintree Local Highways Panel for the year 2024/25 and that the schemes which had been approved had a total value of £184,738. A sum of £19,156 remained available for expenditure. However, it was not proposed that this sum should be allocated at this time.

Members of the Panel were reminded that a Chairs' Panel comprising Essex County Council's Cabinet Member for Highways, Infrastructure and Sustainable Transport and the Chairmen of each Local Highways Panel across the County had been established to consider larger scale and more expensive highway schemes and to determine if these should be funded. Details of the schemes within the Braintree District which had been approved by the Chairs' Panel were set out in the report. These schemes had a total value of £117,000. Specific reference was made to scheme LBRA163006 – (Walking) Footway, Boars Tye Road, Silver End Estimated Cost: -



£106,500. The comments column of the report schedule incorrectly referred to the year '23-24' instead of '24-25'. It was agreed that this error should be corrected.

Jennifer Boxall, Essex Highways, to amend the schedule of funded schemes as indicated above.

6. Schemes Awaiting Funding:

Consideration was given to a 'Schemes Awaiting Funding' report, which included information about proposed schemes submitted for funding. These schemes had a total estimated value of £303,800.

It was reported that Braintree Local Highways Panel's budget for 2024/25 was £203,894 and that schemes with an estimated value of £45,300 had been identified for possible funding.

Members of the Panel were reminded that a Chairs' Panel comprising Essex County Council's Cabinet Member for Highways, Infrastructure and Sustainable Transport and the Chairmen of each Local Highways Panel across the County had been established to consider larger scale and more expensive highway schemes and to determine if these should be funded. It was reported that schemes within the Braintree District which had an estimated value of £258,500 had been identified for possible funding via the Chairs' Panel.

Casualty reduction schemes would be funded from a central fund derived from the budget for the Chairs' Panel.

Members of the Highways Panel were not requested to recommend any schemes for inclusion in the Panel's programme of work for 2024/25, but they were asked to endorse removal from the list those schemes which had been categorised as 'red' as they did not meet Essex County Council's criteria.

When considering scheme LBRA212038 – (Traffic Management) Traffic Calming measures including gateway features and a footway, London Road, Feering, Estimated Cost: - Not applicable (in validation), it was agreed that the description of the scheme should be amended from the provision of gateway features to the provision of a vehicle activated sign. This change would require a speed survey to be carried out.



Jennifer Boxall, Essex Highways, to amend the description of scheme LBRA212038 from the provision of 'gateway features and a footway' to the provision of a 'vehicle activated sign' and to arrange for a speed survey to be carried out.

When discussing scheme LBRA202020 – (Traffic Management) Traffic management improvements, Braintree Road, Gosfield, Estimated Cost:- Not applicable (in validation), it was reported that this scheme had been approved by Essex County Council's Cabinet Member for Highways, Infrastructure and Sustainable Transport in accordance with a Cabinet Member Action, subject to the results of the latest speed survey to be carried out complying with the criteria for a reduced speed limit. Jennifer Boxall, Essex Highways, to implement scheme LBRA202020, subject to the results of the latest speed survey complying with the criteria for a reduced speed limit.

In discussing scheme LBRA232088 – (Traffic Management) Speed reduction and weight limit, B1053 Braintree Road between Wethersfield and Shalford, Estimated Cost: - Not applicable (status assessed as 'red'). It was agreed that this scheme, which had been assessed as 'red' as it did not meet the criteria, should be removed from Braintree Local Highways Panel's list of potential schemes and that Wethersfield Parish Council should be advised about its removal and the reason for it.

Jennifer Boxall, Essex Highways, to inform Wethersfield Parish Council that scheme LBRA232088 has been removed from Braintree Local Highways Panel's list of potential schemes on the basis that it has been assessed as 'red' as it does not meet Essex Highways' criteria.

Reference was made to scheme LBRA242020 – (Traffic Management) Traffic calming measures, Bulford Mill Lane, Cressing, Estimated Cost: - Not applicable (status assessed as 'red'). In view of the discussion earlier in the meeting (Minute 2 (Public Question) refers), it was agreed, that despite being categorised as 'red' as it did not meet Essex Highways' criteria, this scheme should remain on the schedule of 'Schemes Awaiting Funding' to enable further investigation to be undertaken.

DECISION: That it be recommended that the following schemes, the status of which has been assessed as 'red' as they do not meet Essex Highways' criteria, are removed from Braintree Local Highways Panel's list of potential schemes: -

BRAINTREE LOCAL HIGHWAY PANEL REPORT 2 - SCHEMES AWAITING FUNDING LIST

Following a review of the LHP process, the allocation of the LHP capital budget will be adjusted for the upcoming period. The Panel is requested to provide funding recommendations for a two-year Rolling Programme of works, for which a total funding of £611,400 has been agreed for the Braintree LHP.

To facilitate these funding decisions, the 'Schemes Awaiting Funding List' has been divided into two distinct reports:

Report 2-A: Priority Schemes List – This report details schemes that have completed the design phase and are ready for immediate implementation.

Report 2-B: Schemes Awaiting Funding List – This report encompasses all other schemes currently awaiting funding.

Panel members are advised to prioritise funding recommendations from Report 2-A in the first instance. Subsequently, any remaining budget can be allocated to schemes identified in Report 2-B.

Upon receipt of the scheme recommendations, a comprehensive programme will be developed, outlining delivery timelines for each selected scheme. An update on this programme, covering both financial years, will be presented at the next LHP meeting.

It should be noted that due to the LHP no longer validating new scheme requests, Report 2-B exclusively contains schemes that have undergone prior validation.

Please note that as the Chairmen's Panel will not convene during the 2025/26 financial year, schemes previously awaiting their funding decisions have now been reverted to the LHP's Schemes Awaiting Funding List.

The Schemes Awaiting Funding, as summarised below, have an estimated total cost of £382,200.
