3.	Minutes of Previous Meeting	
	The minutes of the meeting on 15 th December 2022 were agreed as a correct record.	



4. Matters Arising from Minutes of the Previous Meeting

LCHE202018 – Valley Bridge – road safety audit had been completed.

LCHE182006 – Savernake Road – the costs from statutory undertakers were received. Diversion cost for Vodaphone currently stood at £170,000.00, Cadent Gas was £342,000, Virgin Media was £307,500 and the estimated carriageway widening and footway scheme construction amounted to £70,000.00. This was against the allocated design budget of £13,000.00.

LCHE172044 – Writtle – Verge Improvements – the parish council decided after the consultation for the scheme not to continue.

LCHE203005/LCHE203006 – Salt bins for Hillside Grove and Cherry Garden Lane – both schemes to install salt bins on Hillside Grove and Cherry Garden Lane are currently in validation. It was found feasible to install a salt bin by Cherry Garden Lane but there could be issues with finding a suitable location regarding the salt bin for Hillside Grove.

LCHE155026/LCHE175010/LCHE215001 – Bus shelters at various locations – it was noted that the progression of bus shelters in Essex was on hold due to a countywide audit. Jon Simmons advised that the contracts are not in a position to take place. Cllr Lardge expressed that for her entire term, there had been no bus shelters put in place in Essex. The ECC officers advised that the agreement process was lengthy and that other factors such as COVID had delayed the process. The panel was reassured that the end was in sight.

The panel was also informed about the progress of the red schemes and was informed that there were a couple of adjustments that needed to be made.

5. Report on Funded Schemes 2022/23

The Panel received an update on the schemes in the Funded Schemes Programme for 2022/23. The update detailed all the schemes which had been completed so far:

LCHE192040 – A414 Danbury – Rout Based Strategy – draft version of the strategy was going to be circulated soon. Cllr Goldman then queried why this was considered as completed on the funded scheme list provided. This was considered an error.

LCHE182006 – Savernake Road – the panel was updated regarding this scheme as above with updates of the costs from the statutory undertakers.

LCHE154009 – Princes Road – Footway/Cycleway – the panel was advised that due to the works outside the school, the scheme was to be reprogrammed during the school holidays. This was to carry over to 2023-24. The Panel were also advised that the scheme would require a top up and the Design Team were waiting on a target cost for the scheme.

LCHE152104 – Well Lane to The Heights – Service Road, Danbury – One Way – the design was being finalised and would be circulated to Cllr Spence.

LCHE188001 – Footpath 76 Galleywood – Markland Close to Rignals Lane – Surfacing – the scheme was to be delivered by Highway Maintenance and Operations team. This was to carry over to 2023-24.

LCHE182009 – B1008 Ford End – Kerbing improvements – the scheme had been passed to the Design Team and awaiting implementation.

LCHE202010 – Bulimers Way, Ongar Road & Lordship Road, Writtle – 7.5T weight limit signing – this scheme to carry forward into 2023-24.

LCHE202036 – Littley Park Cottages, Littley Park Lane, Hartford End – Road markings – bird nesting season delayed the vegetation removal and the implementation of the scheme. This was to carry forward to 2023-24.

LCHE202038 – Maltese Road, Chelmsford – Traffic management improvements – the panel was advised that there had been objections received regarding this scheme. It was advised that the residents were the ones who had objected. Jon Simmons advised that they were seeking Cabinet Member Action to allow the scheme to continue

LCHE212005 – The Street and Back Lane, Little Waltham – Traffic management improvements – design had been completed and there had been a few changes requested by the parish council. The scheme was to be implemented on 2023-24.

LCHE212012 – A1245 Rettendon RAB, j/w Hawk Hill, Rettendon – Signing – the scheme to slip into 2023-24 as permits would be needed from Network Rail and due to traffic management requirements. Cllr Grundy asked if permission would be needed. Jon



Simmons advised yes as Network Rail were quite protective of their lines.

LCHE142002 – Main Road (at northern Broomfield Parish boundary), Broomfield – Gateway treatment – to be moved to Quarter 4 as the scheme needed to be changed to Design Only due to possible changed in parish boundary in March 2023.

LCHE182053 – Millburn Crescent Chelmsford – Layby – the implementation of the scheme had been delayed by land acquisition from CCC.

LCHE212034 – Little Waltham – Traffic review – the data from the ANPR survey completed in January 2023 was currently under review.

AGREED that the Funded Schemes List be noted.

6. Report on Schemes Awaiting Funding

The panel was updated regarding the schemes awaiting funding. They had been updated with the changes and overall status of the funding for the rest of the year. The panel was advised that, as agreed at the ECC Full Council on February 2023, the budget for the twelve Local Highways Panel on 2023/24 was to remain the same as 2022/23. It was also noted that in 2023/24 part of the LHP funding was to be set aside for carriageway improvements and that, as in 2022/23, the Casualty Reduction Sites The panel was then advised of the potential carry forward schemes from 2023/24, the footway improvements 2023/24, and the LHP funding for 2023/24.

Cllr Lardge asked ECC officers how the footway and carriageway improvements lists are compiled. It was advised that there was a Highways inspection regime whereby defects were identified from routine inspection from Highways. The inspections were looking for those footways and carriageways that would benefit from additional works. Cllr McGuiggan then asked if there would be a list soon regarding the footway schemes, footway minor works, and carriageway improvements to be undertaken in 2023/24. ECC officers advised that there would be a list and they would get back to him. Cllr Daden then asked regarding the quality of the material/equipment. It was advised that Essex was always looking at flexible and sustainable materials.

Regarding funding, it was advised that CLHP schemes came from capital funding, which £176,875.00 would be allocated to carriageway improvements, £250,000 footway schemes and £250,000 footway minor works. Cllr Goldman expressed her

frustration on what was perceived as a funding cut on the schemes and decisions were made from a presumedly undemocratic group. Cllr Steel intercepted that this was just a redirection of the monies and that the Panel would still be in control of the funding.

(Cllr Scott entered the meeting at 13:35)

Cllr Lardge queried what constituted as carriageway improvements. Dan Mclean advised that it would be some patching and resurfacing of small scale sections. Cllr Mackrory then asked for clarification surrounding the decision-making on the schemes' list in which Dan Mclean reiterated that this had been agreed on the February ECC Full Council in which it was agreed that there would be £4 million allocated for capital LHP projects. It was also advised that the scope had changed and the money had been redirected. Dan Mclean also advised that there would also be a Chairman's Panel where schemes outside of the Panels budget could be considered. There would be an additional budget within the Chairman's panel and CLHP would be able to bid for schemes. It was unknown how much this budget would be.

The panel then discussed whether to allocate the schemes awaiting funding. Cllr Massey initially advised to review the commission schemes and allocate less than wait throughout the year. However, after further discussion that there would only be around £47,000.00 after the carry forward schemes for 2023/24, the panel **AGREED** to hold off allocating the schemes until the **15**th **June 2023** CLHP.

Cllr Robinson expressed his concern regarding *LCHE224005*, junction improvements by Broomfield Road, which was still in validation despite being raised that there could be a danger to cyclists. Cllr Daden has also added that some of the cycle paths were placed in an opposite direction. Jon Simmons advised that this would be looked at in the June Panel meeting.

AGREED that the Schemes Awaiting Funding List be noted.

7. OTHER BUSINESS

Cllr Daden raised a query regarding the point of advertising regarding the sponsorship of roundabouts. It was advised that roundabout sponsorship is a City Council matter – even highways roundabouts.

Cllr Scott raised concerns from local residents regarding the RideLondon route going through Little Baddow and requested information regarding road closures and times. It was advised that

CHELMSFORD LOCAL HIGHWAY PANEL REPORT 2 - SCHEMES AWAITING FUNDING LIST

This Schemes Awaiting Funding List identifies those scheme requests, which have been received for the consideration of the Chelmsford Local Highways Panel (LHP).

In February 2023 it was agreed, at ECC Full Council, that the 2023/24 Capital Budget for the twelve Local Highway Panels would remain the same as 2022/23. As in 2022/23 the Casualty Reduction Sites across the County are being funded from a central pot of monies derived from the existing LHP funding allocations.

Also, in 2023/24 part of the LHP funding is being set aside for carriageway improvements. This has reduced the overall Chelmsford LHP budget allocation for highway improvements from the Schemes Awaiting Funding List to £250,000.

An additional £500,000 is being provided to the Panel to allow Members to prioritise Footway Schemes and Footway Minor Works to be undertaken in 2023/24. Outside of Panel meetings Members will be provide with separate lists detailing Footway Schemes, Footway Minor Works and Carriageway Improvments. Members will be asked to Prioritise those schemes they wish to be undertaken in 2023/24.

In the April 2023 Panel meeting it was agreed to fund some of the 2022/23 Carry Forward schemes using the available 2023/24 LHP Cpaital Budget. We are currently awaiting a decision from ECC Finance on the funding of all 2022/23 Carry Forward Schemes in 2023/24.

A Sub-Group of the Panel met in January 2023 to consider the Schemes Awaiting Funding List. The Sub-Group funding recommendations are identified within this report as P1/P2, whilst those to be Archived as A.

As such we would ask the Panel to Prioritise those additional schemes they would like to see delievered in 2023/24 subject to the available funding. The Panel may also choose to remove any schemes they would not wish to consider for future funding.
