1.	Welcome & Introductions Cllr Platt welcomed everybody to the hybrid meeting of the Tendring Local Highways Panel, including invited guest Matt Cook – Clerk at Alresford Parish Council.			
	Feedback received from clerks who attended previous meetings has been positive. It was suggested and agreed that attendance of Parish Clerks could be increased from one to two Parish/Town representatives per meeting for future meetings.

4.	Matters arising from minutes of the previous meeting Item 4. Cllr Nick Turner (TDC) questioned if a site visit had been undertaken to address issues of the PROW becoming a cycle route. James Drabwell (EH) advised that no site visit had been taken – James Drabwell (EH) to schedule a site visit.	Chair		



Item 5. Cllr Frank Belgrove (TDALC) was asked to write to Cllr Mark Platt (ECC) and Cllr Lee Scott (ECC) regarding maintenance and vegetation blocking, it was advised that some maintenance could be packaged as schemes - awaiting response. CC Member Alan Goggin referred to a series of schemes known as the B1027 projects where previous cost figures were provided as a guide. It was proposed to use the following amounts already discussed and agreed retrospectively to each project for completion in Q4 : - LTEN202023 - £5,000 - Alresford • LTEN202024 - £4,000 - Thorrington LTEN202025 - £3,000 - Great Bentley • LTEN202026 - £5,500 - Various • LTEN202027 - £4,000 - Flag Hill, St.Osyth Item 6. Cllr Frank Belgrove (TDALC) asked if the bollard replacement in Silett Close, Clacton on Sea would come under maintenance – awaiting response. Previously, Cllr Alan Goggin (ECC) and Cllr Mark Platt (ECC) advised the panel that they would contact the Cabinet Member, Cllr Lee Scott (ECC) to ask for alternative options on maintenance to allow small schemes to be expedited more quickly when Ringway Jacobs did not have the capacity within the financial guarters, this was still being explored. Item 7. Cllr Frank Belgrove (TDALC) asked for an update (to be forwarded to Cllr Guglielmi ECC) on scheme LTEN183006 Colchester Road, Elmstead crossing point. James Drabwell (EH) would explore in terms of the progress of the design process in time for the next meeting. Other matters discussed Countywide Bus Shelter Update: ECC Members that attended the Place Services Committee meeting on 19<sup>th</sup> January advised that after receiving a presentation from Helen Morris (Head of IPTU), the ECC programme on Bus Shelters is progressing although information is still required from Tendring and Basildon Councils. Cllr Daniel Land (ECC) informed the panel that he had emailed Ian Davidson to explore if any action from TDC had progressed this further and was advised that discussions between TDC & ECC were taking place on this matter. Cllr Alan Goggin (ECC) advised that, he was advised, that no funding bids were received from bus shelter companies until recent developments were built. Cllr Ivan Henderson (ECC) noted that there has been in increase in graffiti on bus stops.

- Cllr Alan Goggin ECC) suggested that recommendation 3 remain, due to the probability that there will be village signs funded by the developer.
- There was much discussion about different views of unspent but allocated projects and funds. Cllr Goggin mentioned discussions and meetings with the portfolio-holder where the subject had been clearly explained. The Committee agreed to allocate funds to existing and advanced schemes to utilise much of the £200,402 budget to be allocated. Agreed.

The Panel may also remove any schemes they would not wish to consider for future funding.
